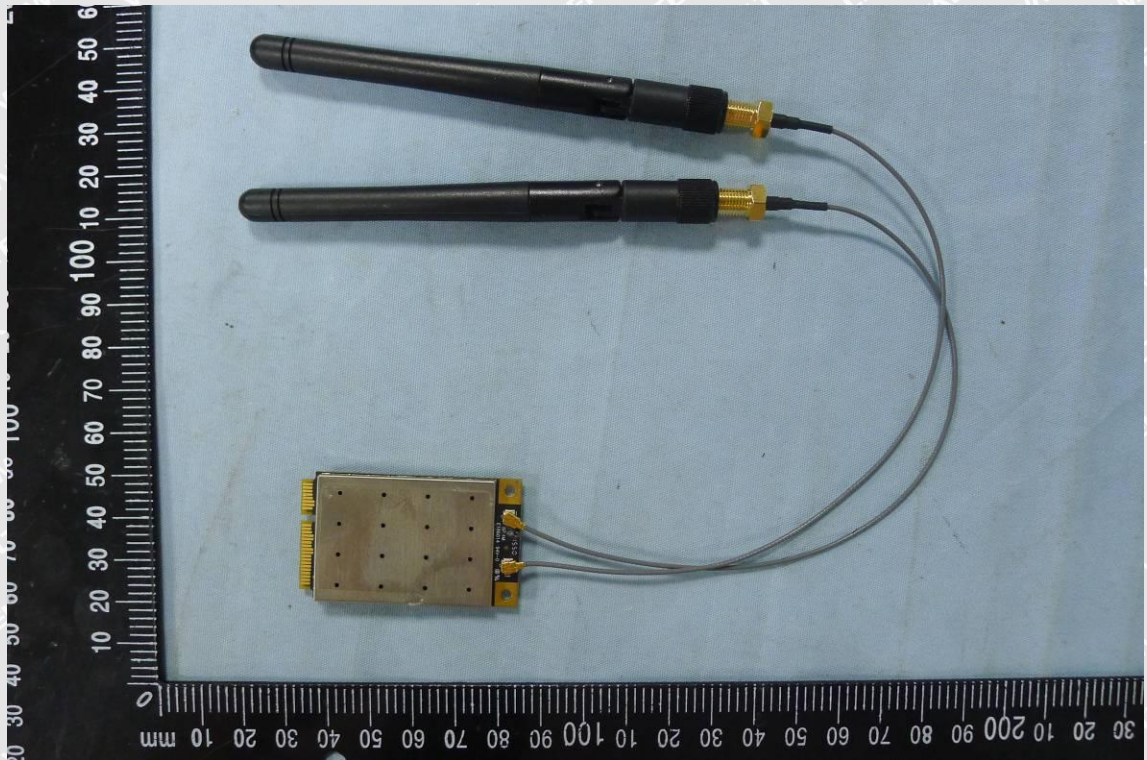

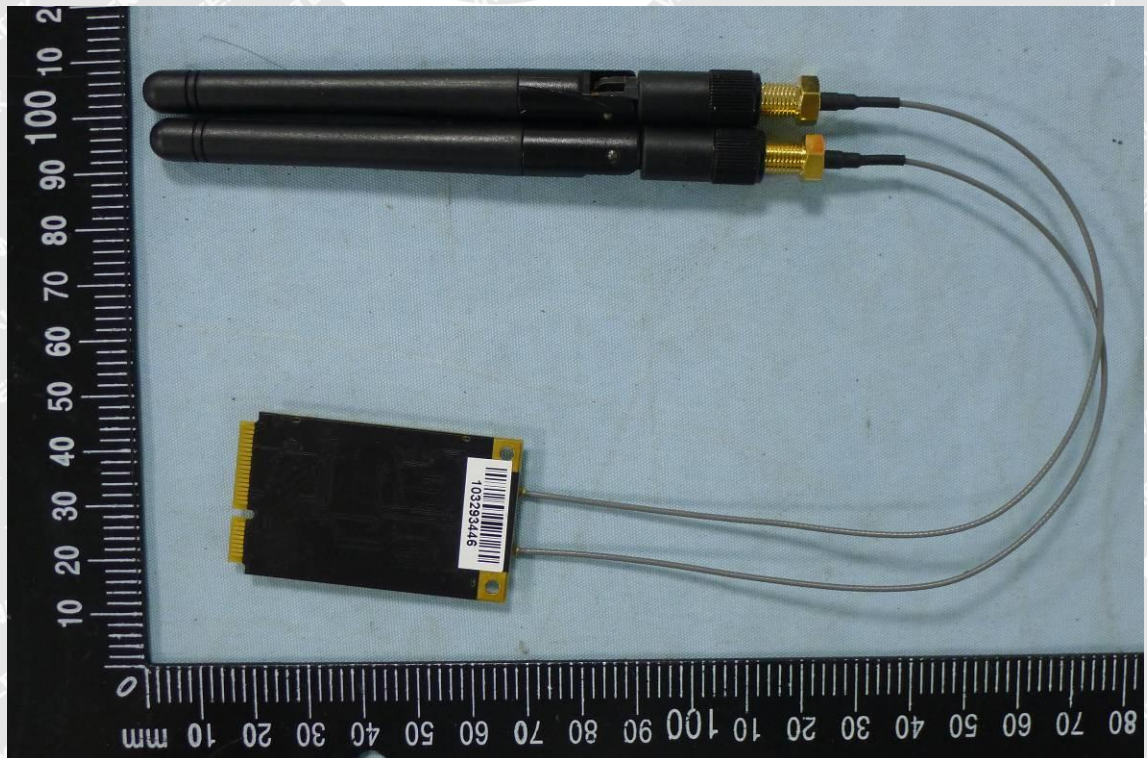

Description: Internal view

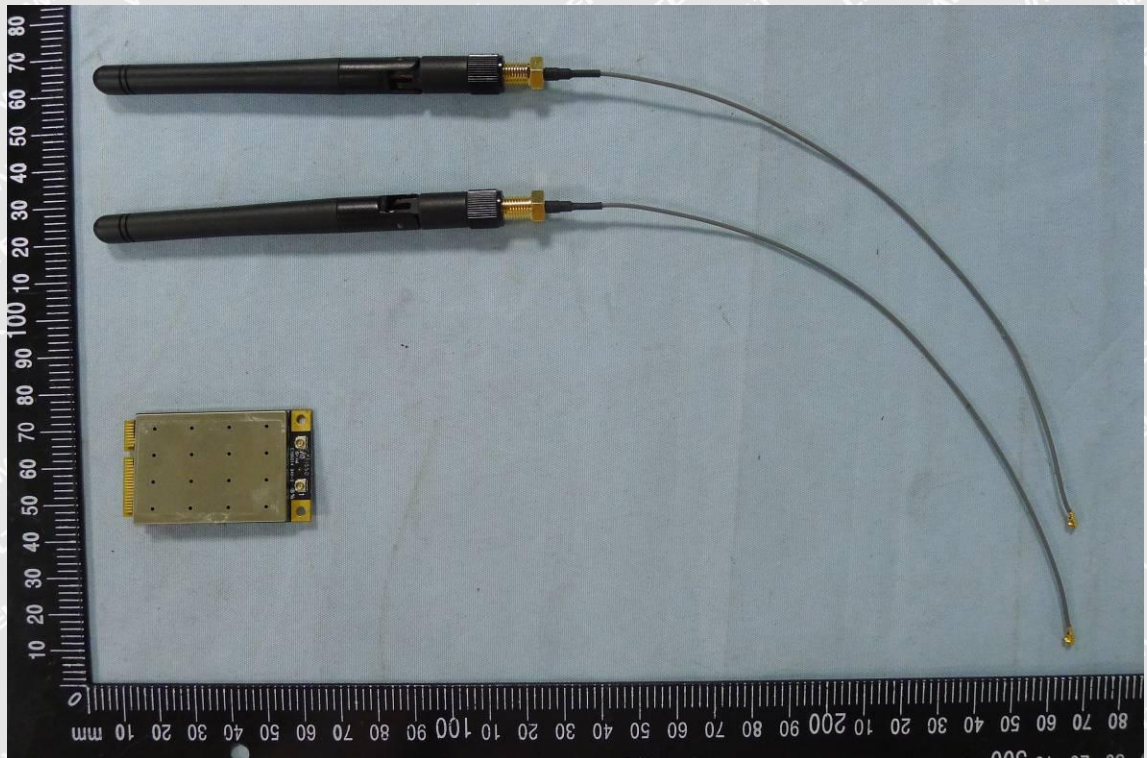

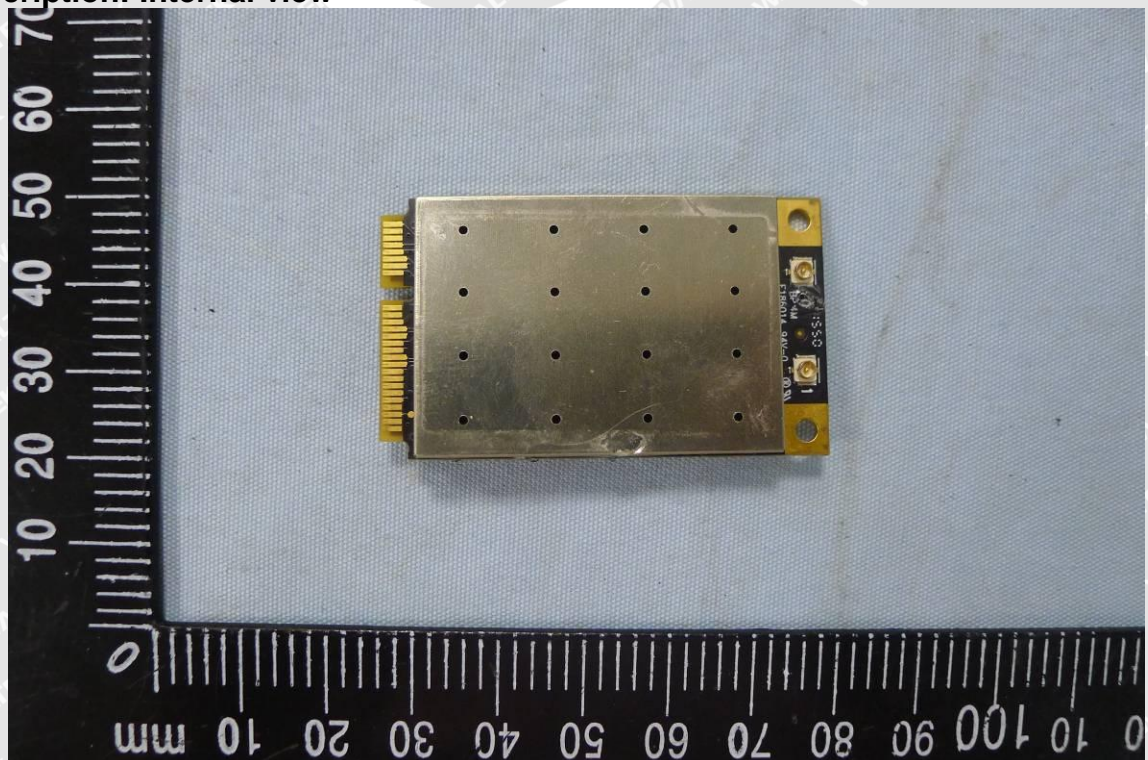

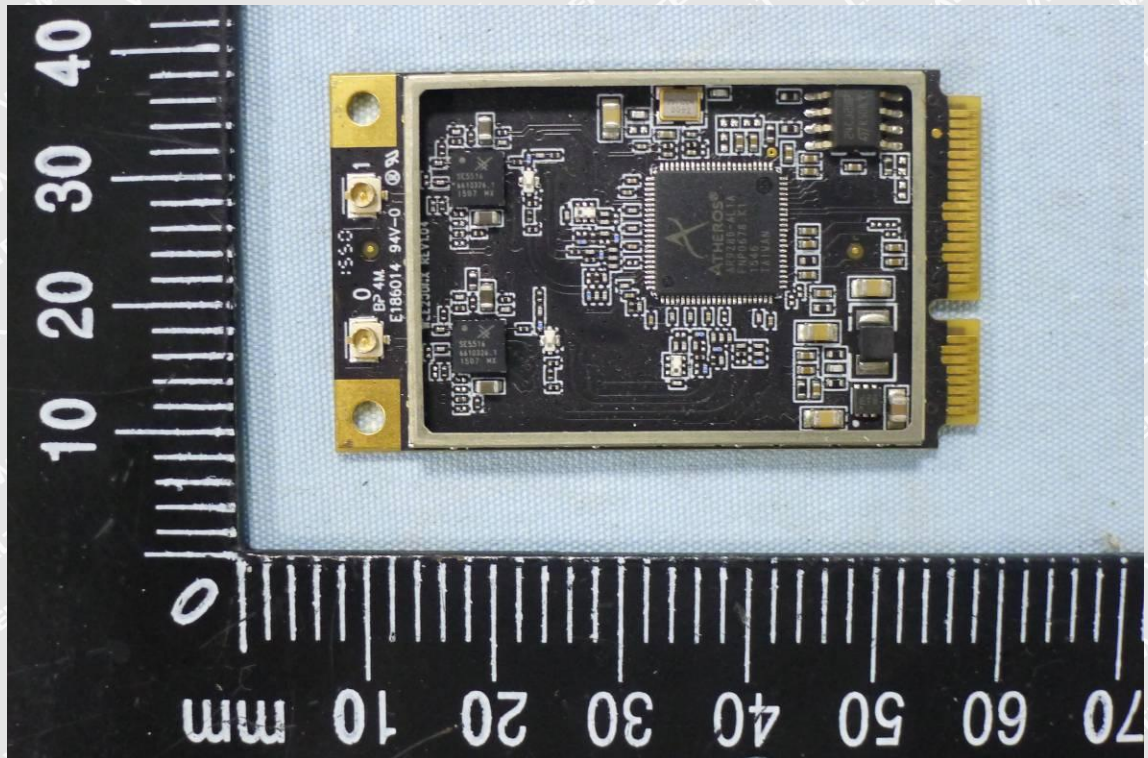
